TERMS & CONDITIONS

All listed tuition is for the entire summer term, except where noted. Fees are not pro-rated for students entering after the term has started (except for individual lessons). The school may dismiss any student who misses two consecutive lessons without notification; who has a pattern of absences; who is consistently tardy; or who fails to adhere to their payment schedule. As a courtesy to the teacher, we ask you to call the school in advance when a student will be absent. Payments must be made for all missed lessons. There is no refund for classes missed because of a student absence. Third Street does not require a teacher to make up any lessons cancelled by students.

Third Street Music School Settlement reserves the right to cancel any class due to insufficient enrollment. In such cases, all unused tuition fees will be refunded. If the school cancels a lesson or class because of teacher absence or bad weather, the class will be rescheduled or a credit will be issued.

Tuition and registration fees for group activities and individual lessons are non-refundable and non-transferable, with two exceptions: 1) for individual lessons that an instructor is not able to give; 2) for a class that is cancelled due to insufficient enrollment.

The required deposit, including the \$40 registration fee, is due at the time of registration. No student or family with an outstanding tuition balance is permitted to register until the balance has been paid. There will be a \$35 charge for any check returned by the bank. The school reserves the right to discontinue the enrollment of any student who does not comply with its payment policies.
